

Adair County Schools is providing and administering an insurance program for students and parents as part of our 1:1 Chromebook initiative. Enrollment in the program is completed by submitting the accidental damage form and submitting to the school. This plan covers “accidental damage” to the device and is designed to limit a Family’s financial responsibility for any damages as described in the coverage section below. In addition, each device is covered under the manufacturer warranty that covers the normal operation of the device to ensure that it functions properly. A \$15 pro-rated (non-refundable) fee is optional for the student to take the device home and can be used toward an initial service claim.

By completing, and signing this form, I acknowledge and agree to this policy:

I will bring my device to school each day I am in attendance (other than distance learning)

I am responsible for the care and protection of my device.

I will always supervise my device or leave it in a secure location.

I understand my device is for educational use.

I will charge my device's battery daily.

I will bring my device charged and ready to use each day I am in attendance (other than distance learning).

I will keep my device away from food and drink.

I will report loss, theft and/or malfunction immediately.

I will practice good digital citizenship.

I will not change the appearance of my device with drawings or stickers. I will keep barcodes on my device.

I understand that my device is subject to inspection at any time without notice and remains the property of Adair County Schools.

I will follow the policies outlined in the Code of Acceptable Behavior & Discipline and the Acceptable Use Policy at all times.

I agree to return the device in good condition at the end of the school year or if I terminate enrollment at Adair County Schools for any reason.

I will use common, appropriate care, while using technical equipment while in my possession, equipment will be kept clean. "Clean" only with an alcohol based cleaner, such as alcohol based Windex – Do Not Use an Ammonia Based Cleaner – as, this could damage the device.

I have read, and agree to comply with this technical equipment Check-Out Agreement. I understand that no web-filtering system is perfect and the parent/guardian is responsible for ensuring appropriate supervision of their child(ren), while accessing the Internet on Adair County Schools equipment.

I also understand that I assume accountability and responsibility for use and condition of any Adair County Schools equipment that I have checked out. I understand that I am personally liable for:

- The replacement cost of the item (\$255), If not returned; or
- The amount required for repair, and/or replacement parts, if the device is damaged when returned.
